**Resolution Authorizing the Formation of Health Care Task Force Supporting Medicare for All Bill
 (H.R. 676)**

WHEREAS almost 50 million Americans do not have health care benefits at all and millions more have inadequate health care and millions of children are without health care because parents cannot afford it; and

WHEREAS this issue is exacerbated by the current declining economy forcing employers to shed millions of

jobs and with it health care coverage for workers who without jobs and little hope of finding one, now cannot afford health care for themselves and their families, and

WHEREAS the time has come for a coordinated effort among all the labor central bodies in the Greater St. Louis Bi-State Region to supplement and coordinate their efforts so that Organized Labor locally can be a more forceful voice on this crucial issue with our elected officials and the public,

THEREFORE BE IT RESOLVED that the Greater St. Louis Labor Council authorizes its support and endorsement for the formation of a regional Greater St. Louis/Southern Illinois Labor Task Force Supporting Medicare For All (H.R. 676) and

BE IT FURTHER RESOLVED that this Task Force invite all the Central Bodies of the AFL-CIO and Change To Win in the St. Louis and Southern Illinois area known as the Greater St. Louis Metropolitan Region to participate in this Health Care Unity Task Force and

BE IT FINALLY RESOLVED that this new Task Force, without compromising our goals, be encouraged to work in coordination and cooperation with any and all community, social, religious, civic, business and labor groups supporting the improvement of health care nationally along the lines of H.R. 676, the Medicare for All bill, knowing that some may have other options, but all striving for the singular purpose of insuring that ALL Americans have access to affordable health care quickly.
