Official Minutes
April 20, 2010

The meeting of the St. Louis Labor Council was called to order by President Robert Soutier at 7:30 p.m. on Tuesday, April 20, 2010.

President Soutier led the delegates in the invocation, followed by the pledge of allegiance to our country's flag.

MOMENT OF SILENCE

A moment of silence was observed in honor of Jo Ann George, wife of Tom George, President of IBEW, Local #1, who passed away after a long battle with cancer.

ROLL CALL

AFFILIATIONS

A motion was made, seconded and approved to accept the affiliation of the St. Louis Police Officers' Association as new members of the St. Louis Labor Council.

SEATING OF DELEGATES

President Soutier called Christopher Eisele, from IBEW, Local #1455 to the podium and gave him the oath of office to represent his union as a Delegate to the St. Louis Labor Council.

APPROVAL OF MINUTES

A motion was made, seconded and approved to accept the March 16, 2010 meeting minutes as printed. Copies of the minutes were available at the entrance of the room.

SPECIAL ORDER OF BUSINESS

President Soutier invited Mark Woolbright, IAFF 2nd District Vice President to the podium to make a special announcement. Mark, in turn introduced Rich Menda, Fire Fighters, Local 2665 Bus. Mgr.; Jennifer Stullman, Local 2665 Political Activist; and Bill Esterline, Chairman Pattonville Fire Department to help him present checks and cash totaling \$13,680, collected from his members, to be given in support of the \$5 for the Fight Fund.

President Soutier accepted this donation with much thanks. A standing ovation was given by the membership, as this was the largest single donation ever made to the Fund. This extremely generous contribution came at a time when the \$5 for the Fight Fund was completely depleted and in dire need of being replenished. It is with sincere gratitude that we thank the Fire Fighters, as many union families will benefit from their kindness, help and generosity.

REPORTS OF OFFICERS **VICE PRESIDENT'S REPORT**

First Vice President, John Ebeling read the Executive Board report as follows:

EXECUTIVE BOARD REPORT St. Louis Labor Council, AFL-CIO Location: Machinist's District No. 9 Thursday, April 15, 2010

The April 15, 2010 meeting of the St. Louis Labor Council, AFL-CIO Executive Board was called to order at 9:00 a.m. by President Robert Soutier.

Also present were Randy Kiser, AFL-CIO; Marcia Cline, United Way; and Karen Lyons, Labor Council.

President Soutier asked Randy Kiser to begin the meeting with his announcement.

Randy Kiser informed the Board of the upcoming Labor 2010 Political Training session which will be held Saturday, May 22, 2010 from 9:00 a.m. to 4:00 p.m. As yet, there is no location set, but he will let everyone know as soon as the venue is acquired. This will be updated training which will focus on current issues and be pertinent to everyone; union members, leadership, activists and anyone interested. This will be a "no cost" training session and a training manual will be included. Randy encouraged everyone to attend.

President Soutier reminded the Board of the May 6th date change for the May Executive Board meeting.

President Soutier asked Karen Lyon's to inform the Board of the upcoming food packaging session.

Karen told the Board that they are scheduled to help package food for the organization "Kids Against Hunger" on Saturday, April 24, 2010 from 9:30 a.m. to 11:30 a.m., and asked them if they would make a contribution to this organization to help offset the cost of materials. A total of 47 people signed up for the session to be held in St. Charles County. They are expected to package 50 cases of food, each containing 216 packaged meals to provide nutrition to children around the world.

President Soutier updated the Board on the Labor Club meeting change. The meeting will now be held at GCC/IBT, Local #6-505 on Tuesday, May 4, 2010 at 6:00 p.m. This meeting will be between Labor Club presidents and Labor Council Executive Board members to make clear the rules and regulations of the clubs.

President Soutier asked the Board for volunteers to form an interview committee for COPE endorsed Senate race candidates on Wednesday, May 19, 2010 at the Labor Council office. Interviews will begin at 9:00 a.m. and be 15 to 20 minutes long for each candidate until all candidates are heard. The committee will include Pat White, Mark Staffne, Tony Ellebracht, Jerry Feldhaus, David Zimmermann, Mark Woolbright and Bob Soutier.

Marcia Cline gave a report on the "Surviving Layoff" seminar that was held on Tuesday, April 13, 2010 at the Machinists' District 9 Hall. Marcia announced that the seminar had been a huge success and they felt that it gave a good number of members much needed information on coping with their situations and insight on how to move forward. They are hopeful they will have another seminar in the near future for persons who were not able to attend this one.

John Ebeling, Vice President Local #6300 warned the Board about a company called "City Graphics Printing" located in St. Louis on Chippewa who are passing themselves off as a union shop. He wanted everyone to know that they are not a union shop and to pass that word so that your members are informed.

Kevin McNatt, President UNITE HERE, Local #74 reported that Pinnacle signed a settlement agreement and that was a big win for them. He also stated that there would be a big rally downtown on the morning of Friday, May 7th for the President Casino workers. They want to put pressure on Pinnacle to hire those workers on at the new River City Casino and Lumiere.

Mark Woolbright, Vice President IAFF 2nd District, informed the Board that the city of St. Louis is talking about outsourcing Emergency Medical Services, which are mostly union jobs. He asked the Board for their support to oppose privatizing EMS. A motion was made, seconded and passed to oppose the privatization of Emergency Medical Services in the city of St. Louis, with President Soutier promising to write a letter to Mayor Slay, with copies also sent to Lewis Reed, President of the Board of Aldermen and Darlene Green, Comptroller, in support of the union Fire Fighters and EMS workers currently working in the city. Woolbright announced that 130 jobs are at stake, however not all 130 are union jobs.

Mike Goebel, Secretary-Treasurer of Teamsters, Local #688 said that the strike at G.S. Rollins is over. He reported that 10 people ultimately ended up walking away from their jobs. He said that they got no political assistance at all, but that the Missouri Displaced Persons division is trying to help those ten individuals.

Pat White, Business Rep, USW/Gas Workers, Local 11-6 announced that Greg Booth, President of the Tri-County Labor Club was currently in intensive care at St. Joseph's Hospital in St. Charles with pneumonia and asked that we keep him in our thoughts and prayers.

Mark Staffne, Business Rep, IBEW, Local #1439 stated that Shriner's Hospital was planning a new building project in 2010 using all union labor.

With nothing further to come before the Board, the meeting was adjourned.

President Soutier reminded the delegation of the Labor 2010 Training Session on Saturday, May 22, 2010 from 9:00 a.m. to 4:00 p.m. at the Sheet Metal Workers, Local #36 Hall.

Soutier also informed the delegates that the Executive Board would be volunteering their time on Saturday, April 24, 2010 to help package food for the organization, Kids Against Hunger. This organization is a local, 100% volunteer-driven international food relief project.

COMMUNICATIONS

President Soutier reported the BLS index at 651.925 for March 2010.

UNFINISHED BUSINESS

Bob Kortkamp, Treasurer MO ARA reminded the delegates of the upcoming Union Labor Mass to be held on Sunday, May 2, 2010 at the Shrine of St. Joseph. He said that this is a non-denominational event and that everyone is invited and encouraged to attend. We honor the lives of our recently deceased brothers and sisters at this event and it would be a perfect time to show our solidarity.

Kortkamp also thanked the delegation for their support of the successful ARA barbeque which was held on March 26 at IAM, Local #837.

Byron Clemens, AFT, Local #420 spoke regarding the Reduction in Force in St. Louis Schools. He also spoke about the possibility of St. Louis opening a Vocational school and they would want it to be a "union" school. President Bob Soutier said that he would help with that effort.

NEW BUSINESS

Nancy Cross, Vice President of SEIU, Local #1 thanked everyone for their support of the Transit Tax (Proposition A) which passed with a higher rate than expected.

Yvette Goods, IBEW, Local #1 spoke regarding St. Louis schools. Yvette also mentioned the IBEW, Local #1 Golf Tournament and coat drive scheduled for May 15th.

Fred Wolfmeyer, Postal Workers asked for help sending postcards to Legislators regarding HR #173 to oppose 5-day delivery.

Mike Chenot, Postal Workers reminded everyone of the Letter Carriers food drive scheduled for Saturday, May 8th to benefit local food banks.

Lew Moye, President CBTU thanked Nancy Cross for her hard work on the transit tax issue.

Moye also announced that the CBTU would have their National Convention in Detroit, Michigan from May 26 thru May 31, 2010. He said that the St. Louis Chapter has sent in two resolutions, one regarding jobs and the second regarding legislation to invest money in infrastructure.

Lew Moye also asked that the AFL-CIO develop a long-term strategy for single payer healthcare.

GOOD AND WELFARE

Tom Sansevere, IBEW, Local #1 thanked the delegates for the reverent moment of silence displayed for Jo Ann George at the beginning of the meeting.

Tom also announced that Greg Booth of IBEW, Local #1 is still in St. Joseph's Hospital in St. Charles recovering from pneumonia. He stated that he is finally out of intensive care and doing better. It was asked that we keep Greg in our thoughts and prayers.

COMMUNITY SERVICES DRAWING

The community services' drawing was held.
